

Open Letter to Prime Minister Justin Trudeau

Dear Prime Minister Trudeau,

I am writing to you about a specific case of the alarming infiltration in Canadian public bodies of the Islamist regime in Iran, which happened in recent years at Simon Fraser University and has now led to a lawsuit before the Supreme Court of British Columbia.

In February of this year, the Director of Canadian Security and Intelligent Services, the Honorable David Vigneault, warned Canadians of the national security threats from hostile foreign governments, particularly through seemingly academic/scientific and business/economic activities. Mr. Vigneault rightfully raised concerns about new attractions in Canada for the bad actors on the world stage, saying: *"Today our adversaries are more focused on intellectual property and advanced research held on computer systems in small start-ups, corporate boardrooms, or university labs across the country."* He added that: *"An insider acting on the behest of a threat actor [...] can steal information outright, and walk it out the door on a flash drive."*

There is no question that the most significant security threats from foreign states come out of Communist China, Putin's Russia, and the Islamist regime in Iran. Among these three regimes, the latter is one of the only two states (alongside Assad's Syria) ever designated by Canada as a supporter of terrorism, and only the latter has seen so much of a threat to the national security that it cannot have an embassy here. However, a combination of ignorance in certain public sectors of the threat posed by the Khamenei's regime and the significant amount of blood money laundered into the Canadian economy by the regime's affiliates, such as current and former members of the Islamic Revolutionary Guard Corps (IRGC) and other regime officials and their relatives and business partners, has led to a situation where some of the Canadian institutions might not be vigilant enough about the foreign and domestic operatives of Khamenei's regime in Canada, or have chosen to close their eyes to their activities.

The case I am bringing to your attention is particularly distinguishable since it involves a Canadian public body's administration acting essentially on behalf of Khamenei's regime in taking revenge on an Iranian dissident whistleblower.

In April 2019, I sent to the President of SFU a report and supporting documents about the presence of agents of the Khamenei's regime at SFU, their records within the regime, and the support they received from within the SFU administration. Of the agents I mentioned, one called **Dr. Shahrokh Jam** is remarkably involved in the regime's ballistic missile program as a prominent researcher for Iran Space Research Center, concurrently works for the brutal police force of the regime- an institution which is responsible for the killings of thousands of Iranian demonstrators in the span of the last three years- and has a dark but well-documented history of oppressing pro-democracy student activists and in his role as the President of the Shiraz University of Technology in Iran. Other individuals mentioned in my report have explicit ties with the IRGC and the office of Khamenei, according to plenty of evidence, including but not limited to the information posted- by them and on behalf of them- on the SFU webpage and using Canadian public resources. Remarkably, Canadian resources were openly used by those individuals to promote a pro-IRGC and pro-Khamenei candidate for the Islamic parliamentary elections in Iran.

The reaction of the SFU administration to my report consisted of each of the following:

- refraining from taking any action to rectify the problems;
- refraining from reporting a matter of national security to any off-campus law enforcement or intelligence institutions, or even to the SFU Campus Security;
- deliberately taking revenge on me using the very Mafia-esque methods Khamenei's regime uses against dissidents inside of Iran, including conspiracy, weaponizing my personal life against me, defamation, and wide-spread cover-up for the wrongdoers on behalf of the SFU administration.

The situation led to a defamation and conspiracy lawsuit, which I took to the Supreme Court of BC, namely,

MASJODY, Masood v. SIMON FRASER UNIVERSITY

After about two years since I sent my initial report to SFU, the administration's cover-up campaign and other malicious efforts on behalf of Khamenei's regime has now extended to the Canadian justice system in the form of unlawful blocking of the discovery process and using extra-judicial factors and recommendations to influence the adjudicators; thereby, defeat the course of justice.

Such efforts will not have a chance of success if the public is kept aware of the situation. However, in the absence of proper public and media scrutiny of the hearings, partly as a result of the pandemic, the actions of the SFU administration on behalf of Khamenei's regime have had some success in covering up for their wrongdoings.

On the other hand, this lawsuit has had some desirable consequences in better exposure of an unhealthy compromising relationship between Khamenei's murderous regime and a regressive portion of the SFU administration and some of its faculty and staff members. These people have effectively been among the foreign soldiers of "Imam" Khamenei in Canada, under the hipocrisy of "Equity, Diversity, and Inclusion" and behind the disguise of the so-called Cultural Relativisim. Based on the documents I have obtained, every reasonable person should be able to make a determination about the conspiracy and defamation campaign by the defendants on behalf of Khamenei's regime and efforts to cover up for the wide-spread wrongdoings of the SFU administration in that regard.

It should be pointed out that besides compromising the national security of Canada, partnering with and acting as the operatives of the Khamenei's regime in transferring sensitive technologies to the world's number one state sponsor of terror can cause irreversible harms to the longstanding prestigious position of Canada as a leading nation-state in support of human rights and victims of dictatorships on the world stage.

I hereby cordially invite you to delegate a representative to attend an upcoming hearing in the aforementioned lawsuit scheduled to be held before the Supreme Court of Vancouver on April 7-8; that will go a long way in promoting the public scrutiny of the hearings and vigilance to the threats posed by the influence and interference of Khamenei's regime's agents and operatives to the national security of Canada and its international reputation.
